Information:

To be eligible for OQHA year-end awards, exhibitors and owners must be members. Please review 2022 Year-end award rules for eligibility. It is the exhibitor's responsibility to know the rules for awards they are competing for.

To be eligible for OQHA Oregon Bred awards, the horse must be registered with OQHA as Oregon Bred. Oregon Bred is a horse who was foaled in the State of Oregon as per AQHA papers.

DOGS: I have a dog with me at the show []

Dogs must be on a leash or secured in a tack room or RV at all times. Loose dogs will result in a \$50.00 fine per incident. Dogs are not allowed in the arena and schooling areas due to the extreme danger of injury to horse and riders. Please pick up after your pet

Canadian at Par for all shows in 2022. Horse must be registered in Canada and owner must have valid Canadian identification.

Any owner or exhibitor, whose personal check (for show fees or stalls) fails to clear the bank for any reason, has 30 days to make the check good. If he or she fails to do so, points for that show will not count for year-end awards and could be subject to AQHA notification. There is a \$35.00 fee for each returned check.
